## 11.0 REPORT OF THE MEDICAL OFFICER OF HEALTH

The Report of the Medical Officer of Health dated January 27, 2021, was presented to the Board of Health for information purposes.

An additional verbal update from the Medical Officer of Health was also provided. The update included the following:

- An update for COVID-19 statistics globally, nationally, provincially, and locally was provided
- Variants of concern are circulating in the province
- The Health Unit is currently completing 100% of contact tracing and case management within the required 24-hour time period
- There has been some confusion surrounding expiration dates with the various acts and regulations (which included the Stay-at-Home Order under the regulation) involved in the January 12 declaration of emergency; they all have different expiry dates.
- The public is encouraged to check the Health Unit website for the current expiry dates
- Any of the dates can be extended, depending on the situation
- The current stay-at-home order is to do with the rising cases, the increase in deaths and hospital admission; the projected modelling has painted a dire picture
- People are to stay at home other than for essential reasons, as outlined by the province
- The message from the province to us is to do what we need to do to make that happen
- The additional restriction in place for the Health Unit district has not been popular and has been controversial, but the province is facing a health crisis and measures need to put in place now to help save lives and protect the healthcare system



- The Health Unit does support physical activity when public health measures are followed
- The north does not have the necessary staff to deal with a crisis of community spread
- The variant of concern is what the Health Unit is the most concerned about; it poses a significant threat. The virus is changing and adapting in order to survive
- Three new variants have been discovered since fall 2020; the UK variant has been identified just south of our district's border
- The local numbers are starting to move in the right direction, but we are not there yet
- The numbers need to be kept low to reduce the burden on the public health and health care systems; people may not be fully aware how fragile the system is
- We have the opportunity to contain this if we do everything we can to act now and not be complacent with the low case numbers in our district
- The Health Unit was scheduled to receive the first doses of vaccine February 1; the shipment was received January 25, so vaccination of residents of long-term care and elder care homes commenced January 26
- The Health Unit will meet the target date of February 5 to get this population immunized with the first dose
- There have been some issues with receiving vaccines; the province is doing all they can under very difficult circumstances
- The Health Unit has been working collaboratively with community partners to get this entire process organized and in place and ready to move as quickly as possible once vaccines are received
- We still need to follow public health directions until we get this under control; countries that followed strict guidelines have typically had their case counts drop and their economies bounce back more quickly; there is good evidence that this works
- According to current data, the vaccines should be effective against the variants of concern
- Dr. Chirico commended all the Health Unit staff, the Board members, community partners, and the communities at large for their patience and for following the public health measures
