7.0 REPORT OF THE MEDICAL OFFICER OF HEALTH

The Report of the Medical Officer of Health dated June 23, 2021, was presented to the Board of Health for information purposes.

An additional verbal update from the Medical Officer of Health, and the Director of the Immunization Strategy was also provided. The report included the following:

- There have been 57 new cases in the district in the last 7 days; there are 8 people in hospital at present
- There have been a total of 562 COVID-19 cases in the district since the onset of the pandemic
- The Delta variant has been identified in 19 of the cases to date; further results of variant of concern testing are pending
- The number of cases identified as the Delta variant in the Province is increasing; this variant is highly transmissible
- Approximately 37% of the district's cases are associated to an outbreak, 26% are close contact related, 14% of the cases are still under investigation, and 2% are associated with travel
- Of the current cases, 46% of the cases are between the ages of 20 39 and 33% are between the ages of 40 59
- An outbreak was declared last week at the North Bay Jail
- To date, 32 of the new cases are associated to the Jail outbreak
- No cases related to this outbreak have been hospitalized
- Mobile testing continues to address health equity considerations
- Mobile pop-up vaccination clinics are underway to ensure that all clients that want to be vaccinated are able to receive it
- The current immunization status of adults in the district is 72% with one dose of the COVID-19 vaccine and 23% of adults fully immunized
- While the vaccine will help, the best way to reduce the spread of the virus is to continue to follow public health measures and Provincial guidelines
- Immunization of youth ages 12-17 is well underway with 51% in the district receiving their first dose; second doses are scheduled to start August 9
- The Ministry target is to have 80% of youth fully vaccinated before the start of the 2021 school year

- Immunization clinics continue to be well attended across the district; clinics are increased as the vaccine supply increases
- A total of 103,170 doses of vaccine have been distributed to date

10.1 Temporary Lending Agreement

Whereas, the North Bay Parry Sound District Health Unit (Health Unit) has a current Credit Facility with the Royal Bank of Canada (RBC) in the amount of \$500,000 for overdraft protection and loan purposes; and

Whereas, the Credit Facility was approved by the Board of Health for the Health Unit on April 23, 2014, and amended on December 23, 2015; and

Whereas, the Health Unit is incurring unusual costs as a result of the COVID-19 immunization strategy and is experiencing cash flow shortages; and

Whereas, the Health Unit has applied for additional one-time funding for the costs related to the COVID-19 immunization strategy to the Ministry of Health (Ministry); and

Whereas, the one-time funding request for the above-noted extraordinary costs is currently in the approval process with the Ministry; and

Whereas, the RBC has agreed to offer the Health Unit a Temporary Lending Agreement for six months for an additional \$1,000,000 under the current Credit Facility, at the same interest rate.

Therefore Be It Resolved, that the Board of Health for the North Bay Parry Sound District Health Unit approve the Temporary Lending Agreement in the amount of \$1,000,000 for six months with RBC.

10.2 **Public Health Funding for 2022**

The following motion was read:

Board of Health Resolution #BOH/2021/06/04 *McGarvey/Guenther

Whereas, the Government of Ontario in its budget of April 11, 2019, initiated a Public Health Modernization process which included a change in municipal cost-sharing from 25% of mandatory public health programs covered by municipalities to 30% of almost all public health programs based on 2018 third quarter spending levels; and

Whereas, on August 21, 2020, the Ministry of Health (Ministry) announced that provincial mitigation funding would be provided to offset the increase to municipal cost-sharing for 2020 and 2021; and

Whereas, the COVID-19 pandemic, which started in early 2020, has further affected municipalities' ability to pay levy increases, it has stalled modernization processes, increased the cost-of-living, and affected the health and well-being of the public, and more specifically, public health clients and staff.

Therefore Be It Resolved, that the Board of Health for the North Bay Parry Sound District Health Unit supports returning to the 2018 cost-sharing formulas at 25%/75%, with 100% provincially funded programs; and

Furthermore Be It Resolved, that the Board of Health supports mitigation funding continue for 2022 to eliminate the additional financial burden of a 42-50% levy increase to the Health Unit's 31 member municipalities if it is not possible to return to the 2018 cost-sharing formula with 100% provincially funded programs; and

Furthermore Be It Resolved, that the Board of Health requests the 2022 public health funding include increases to reflect, cost-of-living increases, public health program changes related to ongoing COVID-19 response, and funding to assist with program and community recovery efforts; and

Furthermore Be It Resolved, that the Board of Health requests a base funding increase to fund an Associate Medical Officer of Health to support the Medical Officer of Health with the continual demands of 24/7 on call coverage that have been highlighted throughout the COVID-19 pandemic; and

Furthermore Be It Resolved, that the Board of Health instructs the Medical Officer of Health and Senior Management to write a letter to the Minister of Health detailing the financial and organizational pressures on public health, including outlining the urgency for establishing the funding levels for 2022 to assist public health and community budget planning.
