The <u>Report of the Medical Officer of Health</u> dated January 26, 2022, was presented to the Board of Health for information purposes.

An additional verbal update from the Medical Officer of Health was also provided. The report included the following:

Health Unit

- The biggest issue recently is the widespread community transmission of COVID-19
- Testing has become more targeted and prioritized for capacity purposes and to maximize limited resources, which means case numbers are under reported
- The Health Unit remains amongst the lowest in terms of cases numbers in the province
- Mitigating harm remains important to prevent the health care system from becoming overwhelmed
- Hospital and ICU admissions along with the number of deaths related to COVID-19 are now the more relevant indices
- While there is some stabilization in hospitalizations, COVID-19-related critical illness remains
- There are some hospitals that are seeing surges in admissions, including pediatric admissions, and tragically, the number of deaths is on the increase with the third largest numbers of deaths reported recently since the start of the pandemic
- The largest numbers of death are reported in critical settings and with the unvaccinated population
- Locally, the Health Unit district has 209 active cases with a percent positivity rate of 15%, 11 outbreaks currently, and sadly, we have had a total 13 deaths locally now
- Case and contact management has needed to be strategically re-evaluated with so much transmission to ensure capacity
- The vaccine is still highly effective, with 56% coverage from infection with at least two doses, 83% less likely to be hospitalized, and 91% less likely to be admitted to the ICU
- The Health Unit continues to prioritize first, second, third, and fourth doses of the vaccine; fourth doses are currently being provided in congregate care settings and should be completed by the end of January
- School-based clinics and after-hours clinics are being provided to address the needs of the 5-11-year-old age group
- The Health Unit's website is updated regularly to display the most current and relevant information
- On behalf of the North Bay Regional Health Centre, they now have their COVID-19
 Assessment Centre up and running which is co-located with their COVID-19 Testing
 Centre
- Anyone that suspects they are COVID-19 positive or are exhibiting mild to moderate symptoms are asked to make an appointment with their COVID-19 Assessment Centre rather than visiting the emergency room

In response to a question raised regarding school absences, the Board was advised that the Ministry of Education is responsible for the type of reporting provided by school boards.
