## **Key Highlights**


- Between 2010 and 2018, the non-traumatic oral health-related emergency department visit rate among adults living in the Health Unit region was more than three times higher than the rate among adults living in Ontario as a whole.
- In 2018, the rate of non-traumatic oral health-related emergency department visits made by • North Bay adults dropped significantly compared to the previous year by about 21.3% with 170 fewer visits made in 2018 compared to 2017.
- In 2018, the rate of adults residing in West & North Nipissing combined who visited the emergency department for non-traumatic oral health-related reasons was over four times the Ontario rate.
- Between 2005 and 2018, the non-traumatic oral health-related emergency department visit rate was highest among adults aged 25 to 34 years for adults living in the Health Unit region.

# Higher rate of non-traumatic oral health-related visits made by adults in the Health Unit region

Between 2010 and 2018, the age-standardized rate of non-traumatic oral health-related emergency department visits made by adults in the Health Unit region was over three times higher than the Ontario rate between the same time period (Figure 1; Table 1).

This rate steadily increased in the Health Unit region from 2005 until 2013, plateaued between 2013 and 2015, and dropped slightly in 2018.

## Drop in non-traumatic oral health-related emergency department visits made by North Bay adults




Figure 2. Crude Rate per 100,000 Population of Non-Traumatic Oral Health-Related Emergency Department Visits, By Region Below the Health Unit Region Level, 2005-2018

In 2018, significantly fewer North Bay adults made visits to the emergency department for nontraumatic oral health-related reasons compared to in 2017 (Figure 2 & Table 2). This represents a 21.3% decrease in the rate from 2017 to 2018, and about \$87,210 in averted spending towards non-traumatic oral health-related emergency department visits (170 fewer visits made, with an estimated minimum cost of \$513 per visit<sup>1</sup>).

In 2018, the crude rate of adults residing in West and North Nipissing combined who visited the emergency department for non-traumatic oral health-related reasons was over four times the Ontario rate.

# Highest rates of oral health-related emergency department visits among adults aged 25 to 34 years




Figure 3. Crude Rate per 100,000 Population of Non-Traumatic Oral Health-Related Emergency Department Visits, By Age Group (Years) and Year, Health Unit Region, 2005 – 2018

Between 2005 and 2018, the non-traumatic oral health-related emergency department visit rate was highest among adults aged 25 to 34 years for adults living in the Health Unit region (Figure 3). Since 2005, the oral health-related emergency department visit rate more than doubled among adults aged 55 to 59 years, and has almost doubled among adults aged 30 to 34 years.

## **Definitions and data sources**

### Definition

### Oral health-related emergency department visit:

Emergency department visits that included unscheduled visits to the emergency department with main problem diagnoses of all non-traumatic oral health conditions (ICD-10 CA codes from K00 to K14 – Diseases of the oral cavity, salivary glands, and jaws). Visits only include residents of Ontario who are aged 18 years or older.

Data sources:

- 1. Emergency department visits: Ambulatory Emergency External Cause [2005-2017], Ontario Ministry of Health and Long-Term Care, IntelliHEALTH ONTARIO, Date Extracted: [2019/07/04]
- 2. Population estimates: Population Estimates [2005-2016], Ontario Ministry of Health and Long-Term Care, IntelliHEALTH Ontario, Date Extracted: [2019/05/12].
- 3. Population projections: Population Projections [2017-2018], Ontario Ministry of Health and Long-Term Care, IntelliHEALTH Ontario, Date Extracted: [2019/05/12].

### Analysis:

#### Age-standardized rate:

The age-standardized rate was calculated by using the Direct Method and standard 2011 Canadian population.

#### **Confidence intervals:**

Confidence intervals (CI) and variances were estimated using the Poisson distribution in STATA IC/14.2 (2014) for all regions.

### Interpretation of a significant difference:

A statistic interpreted as 'significantly different' from another is an estimate found to be statistically meaningful; the difference is unlikely due to chance. Error ranges noted in tables within this report illustrate 95% confidence intervals. If there is no overlap in range between confidence intervals, the difference can be described as statistically significant.
